# Speaker-Vicki Trainor of Delmarva Search & Rescue (SAR)

The proposed locations are circled in red on the attached map. DelDOT is working to add this installation into their schedule and I'll update you when I'm notified. Also, I'm still working with them to determine the ROW for the pipe installation."
